PARISH PRECEPT REQUIREMENT, GRANT SUPPORT, & TAX BASE FOR 2026/2027

I should be pleased if you would let me have details of your Council's Precept Requirement for the year 2026/27 by completing the enclosed form and returning it to me by Friday 23rd January 2026.

Your Precept Requirement should be the amount of your council tax requirement for the year, calculated as required under Section 50 of the Local Government Finance Act 1992, amended by the Localism Act 2011, and must take account of all known items, including parish elections if they are due to be held.

This Council Tax base figure is a fundamental component in calculating your local tax and precept requirements. The table on the next page shows the figure that has been calculated as next year's Council Tax base for the parish.

You will recall that following the implementation of a local council tax support scheme in 2013/14 this resulted in a reduction in the tax base. In order to mitigate the impact of this change the council passed on funding support from central government in the form of a grant. Your grant allocation for 2026/27 has remained the same as 2025/26 and the amount is also shown in the table on the next page.

It is our intention to pay 50% of your Precept Requirement and grant within one month of the start of the financial year, ie, on 17th April 2026 and the remaining 50% paid within six months of the start of the financial year, ie, 18th September 2026.
